WORKING WITH CROSSWAYS CAMPING MINISTRIES

All staff are expected to attend and participate in staff training. All staff must report for staff training on Monday, May 31st, 2010. All staff are expected to work two weekends during the summer. Summer camping programs begin on June 13th, 2010 and end on August 22nd, 2010. Some positions may begin earlier or end earlier, as contracted.

Our programs are committed to providing a caring attitude toward each young person or family camper in the context of a Christian Community. We expect loyal service and have set high standards for employees. We provide a positive and safe environment for all camp participants. Our camps are drug and alcohol free and we expect our summer staff to abide by and maintain that policy. We also expect our staff to display high standards of conduct in local communities during their period of employment.
